Harvest of Hope Pantry helps relieve the financial stress of food insecurity and provides an outlet for the re-distribution of food items to those in need within a non-judgmental, safe and caring environment. We are committed to serving food with high nutritional value. We finished 2014 with an increase of 21% for individual clients served over 2013. Our support goes out to all in need, regardless of religious affiliation.

The Pantry provides a client choice experience, and offers a measure of dignity by allowing individuals and families to shop for food they are likely to utilize. Separate shopping hours are provided for clients with kitchens and those without kitchens. This permits the needs of each group to be better addressed.

During 2014, there were 13,138 shopping visits made by clients without kitchens, and 10,294 shopping visits by clients with kitchens. This is an increase of 12% for clients without kitchens and 48% for clients with kitchens from 2013.

Harvest of Hope Pantry is dependent upon volunteers for service delivery. The primary volunteer positions are Shopping Assistant and Inventory Assistant. Shopping Assistants are key to nurturing client relationships. Inventory Assistants are key to keeping the shelves stocked. The electronic tracking of volunteer time, using Volgistics software was initiated January 2nd. In 2014, volunteers shared 8,195 hours of their time.
