IN 2024 WE ACHIEVED SIGNIFICANT PROGRAM SERVICE ACCOMPLISHMENTS. WITH A TOTAL OF 356 VOLUNTEERS CONTRIBUTING 10,784 HOURS, WE INCREASED THE EFFICIENCY OF OUR OPERATIONS AND BUILT ON THE POSITIVE THERAPEUTIC VALUE OF VOLUNTEER-CLIENT INTERACTIONS. THESE MEANINGFUL CONNECTIONS ENHANCE THE OVERALL EXPERIENCE FOR OUR CLIENTS. . IN ADDITION TO PROVIDING FOOD, THE PANTRY'S RELATIONAL AND EMOTIONAL SUPPORT PLAY A KEY ROLE IN ACHIEVING POSITIVE OUTCOMES. IN TWICE YEARLY QUESTIONNAIRES, 98% OF SURVEYED SHOPPERS AGREED WITH THE STATEMENT "I FEEL WELCOME AND RESPECTED AT HARVEST OF HOPE PANTRY."

OUR COMMITMENT TO ADDRESSING FOOD INSECURITY IS CLEAR IN OUR NUMBERS. IN 2024, WE FACILITATED A TOTAL OF 31,260 SHOPPING VISITS, PROVIDING ESSENTIAL FOOD TO THOSE IN NEED. OUR IMPACT IS UNDERSCORED BY THE DISTRIBUTION OF 1,016,373 POUNDS OF FOOD THROUGHOUT THE YEAR.

RECOGNIZING THE EVOLVING NEEDS OF OUR COMMUNITY, WE TOOK PROACTIVE STEPS TO IMPROVE ACCESSIBILITY. WE INTRODUCED 2 ADDITIONAL MOBILE PANTRIES (FOR A TOTAL OF FIVE), PROVIDING FOOD, ONSITE, TO INDIVIDUALS WHO MAY HAVE TRANSPORTATION OR MOBILITY LIMITATIONS. THESE EXPANSIONS OF SERVICE HAVE NOT ONLY BROADENED OUR REACH BUT ALSO ENSURED THAT OUR PANTRY IS MORE ACCESSIBLE TO INDIVIDUALS FACING FOOD INSECURITY.
